 - 3.Ms. McAdams and Ms. LaRue discussed the previously planned Youth Bike Event in Thornville, confirming the event as a partnership between the Park District and Health Department and that Bike Buckeye Lake was still interested in participating. Ms. LaRue is in contact with Bike Buckeye Lake. The timeframe is expected to be late May/early June for a summer kick-off as kids are getting out of school. The possibility of a bike rodeo arranged and managed by local Boy Scouts was discussed and Ms. LaRue will contact the local Somerset scout leader regarding this.
